>Dear Sir,

>I apologize for taking so long to reply to your message concerning the
>possibility of my providing assistance in the Ministerial Inquiry into the
>Peter Ellis Case. I have just recently returned from a family holiday.
>
>I am intrigued by the opportunity to serve as an expert in this inquiry,
>and would be quite interested in doing so. However, I am not certain that
>I could provide my recommendations in the time frame allotted. Thus, I
>will detail for you below what I believe would be required in terms of my
>time and compensation, and you may then decide whether this is appropriate
>or that you should seek another opinion.

>
>In thinking about the number of taped interviews and transcripts that I
>would need to review, and in light of my other professional
>responsibilities, I believe that I would need 3 or 4 months in order to
>complete the task. I believe, therefore, that I could render a report by
>mid-December of this year. This is assuming that the 18 hours of taped
>interviews alone (exclusive of any other evidence) would require
>approximately 90 hours (5 hours per hour of tape) to fully analyze. I
>normally charge \$150 (U.S.) per hour for this type of service, but this
>seems excessive given the number of hours involved here. Instead, perhaps
>I should estimate a flat fee of \$5000, based on approximately 100 hours of
>work over the course of this task. This should cover not only my own time
>and expenses, but also those of students and support persons who would
>assist with this and my other tasks so that I could devote the necessary
>amount of time to analyzing the evidence.

>I hope I have responded informatively to your questions. Please let me
>know if you require any additional information.
