- that Peter ELLIS and his mother took photographs and were laughing;
- that the sharp sticks were stored in a wooden treasure box round like a pirate's one containing twenty pieces of paper, a lighter, and five sharp sticks. He noted that he had seen a pirate's treasure box on TV and had got toys with pirate boxes.
- that his "bum" was bleeding hard after the sticks were inserted and that after the event he was taken back to the crèche;
- that he was sodomised by "Spike";
- that he was drugged by Peter ELLIS and his mother, including pills, injections and a poisonous drink;
- had needles put in their hand, that the events took place at hospitals and restaurants and at ELLIS' friends' house;
- that ELLIS had taken him and other children to QEII park and dropped them in the deep end of the swimming pool and left them there;
- a circle game at which included who were wearing tins around their necks, that others around the circle were playing guitars, these included Peter Ellis' triends' and family;
- that nine children in the middle of the circle had to hit and kick each other.
- that three female crèche workers took their clothes off and pretended to have sex in the dining room of Peter Ellis' house:
- that the guitar players pretended they were cowboys and were dressed in white suits (at the previous interview they had been in normal clothes) and sang "I'm a cowboy", "Baa Baa Black Sheep", "Ring a Ring a Rosies"
- that some of the people involved had oriental eyes, some had brown skin;
 - that needles were put up his penis, that his penis bled and that the people with guitars cleaned up the blood off the floor; that the children were taken back to the crèche via a building with a trap door (the library?) and they all fell down the trap door, falling approximately four floors to the basement;
 - that the crèche workers had hurt the boys' penises and the girls' vaginas;
- that children were put in an oven;
- that children had their feet tied up, and that they were tied up in a ball and were put into an old oven which was switched on and that there was smoke in the oven, the oven was hot.
- 120. These allegations are not the full extent of the allegations that made. The reported allegations made to his mother were even more bizarre and included the killing of a boy

marriage ceremonies, being buried alive in a cage at the grave-yard, having to dig up bodies at grave-yards and the killing of animals.

121. It is submitted that no Specialist interviewing technique could have prevented from developing his allegations in the way that he was to do but it is submitted that the level of suggestibility in this child was such that no interview after the first one could have been anything other than tainted to a level where it could no longer be of any assistance to the Jury.

122. It is submitted that in case given the level of parental interrogating that took place the importance of having an interview at the time suspicions/concerns arose was imperative.
